The agreement was signed during the grand opening of the China International Import Expo (CIIE), held 5-10 November 2019 at Shanghai's National Exhibition and Convention Center.

In October 2018, Agfa and China Meheco Corporation, a leading distributor and producer of pharmaceuticals in China, signed the original agreement, covering the distribution of DRYSTAR hardcopy solutions. The new contract extends this agreement for an additional two years.

Agfa's DRYSTAR medical imagers and kiosk solutions¹ print digital images from CT, MRI or digital radiography equipment, producing diagnostic-quality images. They are among the fastest on the market from print order to first film print.

The broad DRYSTAR range offers solutions for both centralized and decentralized, diagnostic and high-quality printing. The imagers come with Direct Digital Imaging (DDI) technology, enhanced with A#Sharp technology for consistently sharp images. The DRYSTAR hardcopy films can be used for
